## PLANNING & ZONING COMMISSION SPECIAL MEETING OCTOBER 8, 2019

Chairman David Colbert called the meeting to order at 7:04PM. Alternate member Ben Gray Jr. was seated for regular member James LaPorta.

## DISCUSSION BY THE COMMISSION OF THE TIMING OF THE APPROVAL AND ADOPTION OF THE DRAFT PLAN OF CONSERVATION AND DEVELOPMENT.

Chairman Colbert gave an overview of the statutory process for the creation and adoption of a Plan of Conservation and Development, outlining the work of the subcommittees, the Commission's jurisdiction and statutory method in preparing and adopting a Plan every 10 years, and the final process of the adoption of a Town Plan.

There was clarification from staff that the evening's meeting did not constitute a public hearing and that public input at the meeting was not officially part of the record. It was encouraged that all comments be forwarded in writing.

Witten Information acknowledged as being part of the record included correspondence from the, Conservation Commission, Board of Selectmen, Board of Finance, and email correspondence from Sam Waterston, Joanne Wojtusiak, and Meg McMorrow. Information's submitted that evening was acknowledged including correspondence from Judy Herkimer and John Harding.

## Opportunity for feedback from representatives of Cornwall's boards, commissions, and organizations on the draft Plan of Conservation & Development.

First Selectmen Gordon Ridgway, speaking on behalf of the Board of Selectmen, Ginni Block, on behalf of the Cornwall Housing Corporation, Patrick Mulberry on behalf of the Conservation Commission, and Janet Carlson on behalf of the Economic Development Commission, addressed the Board regarding their partnership roles listed in the draft Plan.

Member of the public were allowed limited time for questions and concerns. Note was again made that the evening's meeting was not a public hearing and their comments were not part of the Commission's record of the Plan.

The Commission, with input from Jocelyn Ayer, addressed the draft Plan, amendments, procedures, etc. and direction and discussion of the process from the meeting to the public hearing proposed for November 12<sup>th</sup>.
