Chairman Anna Timell called the meeting to order at 7:04PM with a quorum established.

Chairman Timell opened the public hearing at 7:05M. All regular members were seated for the hearing and alternate members given permission to ask questions.

Chairman Timell address issues associated with the noticing of the evening's public hearing, including the information on the agenda as to time (none listed on the amended agenda on the website) and information in the May issue of the Cornwall Chronicle listing the meeting as ZOOM. Based on the noticing defects, chairman Timell stated that public hearing would be opened and continued to June 13th, an In-person meeting only at the Cornwall Library.

Chairman Timell read a prepared document in the record (and placed on file) regarding the history of the reformatted regulation project, addressing changes to regulations to address statutory compliance and court process, the addition of 25 definitions for clarity, and the process to make the regulations more accessible and clearer with no change to the intent or expected outcome of the original regulation.

The floor was opened to staff to address information made part of the file.

 Email Confirmation, from the Land Use office to Emily Hulquist at the Northwest Hills Council of Elected Official of the receipt of draft Reformatted regulations sent to the Northwest Council of Government for review to comply with the 35 day statutory time frame and response of no need to review as reformatting does not constitute statutory view.

The floor was opened to the public from comment,

Gordon Ridgeway, Cornwall First Selectman, thanked the Commission for their work on this "important document" to make it clearer, easier to use, and consistent with state statutes.

Nancy Berry spoke in favor, addressing the diligence and thoroughness of the Commission in their long term work on the regulations.

Ann Trowbridge, noting experience relating to land use planning, called the reformatted regulations a vast improvement –shorter, better organized and easier to use.

Nancy Berry raised questions regarding the change of the word "family" to household and when, and why two family dwelling units had been removed from the regulations,

Marguerite Purnell, stating that she would be submitting written comments, addressed issues with the process of statutory link in the regulations. Additional comments were to be submitted.

Hearing no other comments from the audience:
