


Hello Friends,

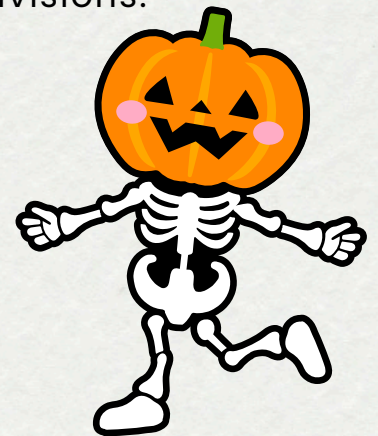
PLANNING AND ZONING COMMISSION | ANNA TIMELL, CHAIR

The Planning and Zoning Commission will next meet on Wednesday November 12 due to a federal holiday on our regular meeting day. The public hearing on the Flaglot amendment to the Subdivision regulations was continued at our last meeting due to the requirement that we must hear from the NHCOC before proceeding. There were no comments for or against at the initial public hearing. We are continuing to review the Subdivision regulations. To that end, the Chair and the Land Use Consultant will attend a Special Meeting of the Cornwall Conservation Commission on November 3 to discuss criteria for open space set-asides in subdivisions.
